Unit as more particularly set forth in the aforesaid Declaration, as last

TOGETHER with the right to use Limited Common Elements appurtenant to the Unit being conveyed herein, if any, and the obligation to discharge any duties associated therewith, pursuant to the Declaration and Declaration Plats and Plans, as last amended.

UNDER AND SUBJECT to the Declaration, to any and all other covenants, conditions, restrictions, rights-of-way, easements and agreements of record in the aforesaid Office, and to matters which a physical inspection or survey of the Unit and Common Elements would disclose.

UNDER AND SUBJECT to that certain Declaration of Restrictions and Covenants, in Instrument No. ______, that certain Operation and Maintenance (O & M) Agreement Stormwater Management Facilities, recorded as Instrument No. 6197650, that certain Post Construction Stormwater Management (PCSM) Instrument Filing Notice, in Instrument No. 6198881 and that certain Post Construction Stormwater Management Plan for Landis Farm, recorded as 2015-0098-J.

BEING part of the premises which J. Samuel Thomas and Marian J. Thomas, husband and wife, and Glenn W. Rohrer and Joyce L. Rohrer, husband and wife, by Deed dated April 16, 2015 and recorded in the Office of the Recorder of Deeds for Lancaster County, Pennsylvania as Instrument No. 6198370, granted and conveyed unto Landis Farm Associates, LLC, a Pennsylvania limited liability company, Grantor herein.

THE GRANTEE, for and on behalf of the Grantee and the Grantee's heirs, personal representatives, successors and assigns, by the acceptance of this deed, covenants and agrees to pay all assessments, fees and/or charges as may be assessed against him, her, them, it, or against the said Unit, from time to time by the Executive Board of Landis Farm Unit Owners Association in accordance with the Pennsylvania Uniform Planned Community Act, 68 Pa. C.S. 5101 et seq., as amended (the "Act"), and further covenants and agrees that the Unit conveyed by this deed shall be subject to a lien for all amounts so assessed, except insofar as Section 5407(c) of the Act may relieve a subsequent unit owner of liability for prior unpaid assessments. This covenant shall run with and bind the Unit hereby conveyed and all subsequent owners thereof.

AND the Grantor shall and will SPECIALLY WARRANT the property hereby conveyed.
